On the above cited subject, it is to inform you that keeping in view the various representations from the field offices, Growers and Managing Director HPMC, Himachal Pradesh, the Government has accorded approval for opening of procurement Centres and procurement of processing grade Apple and Mango fruits under Market Intervention Scheme w.e.f. 28.07.2023 with the condition that the procurement agency will procure the fruits from only those farmers who will give under taking that **"He/She will agree to give their produce under MIS on rates which will be approved by the Government for 2023-24 in future"** till the detailed approval is not received from the Government.

The procurement centres will be manned by HPMC & HIMFED by their own staff as per past practices. 

सेब मण्डी मध्यस्थता योजना- 2023 के अर्न्तगत फलों के प्रापण हेतु दिशा-निर्देश

1. पेड़ से गिरे हुए अथवा क्षतिग्रस्त फलों का प्रापण मण्डी मध्यस्थता योजना के अर्न्तगत नहीं किया जाएगा।
2. फलों को पेड़ से तोड़ने के बाद उन्हें उसी तरह शीघ्र फल एकत्रीकरण केन्द्र पर पहुंचाएं, जिस तरह वे मण्डी में भेजे जाने वाले फलों को फारवर्डिंग एजेंटों तक पहुंचाते हैं।
3. सेब की विभिन्न किस्मों की तुड़ाई उचित अवस्था (परिपक्वता) पर करें अर्थात् फल न ही कच्चे (अपरिपक्व) हों और न ही अधिक पके हुए (अधिक परिपक्व) हों।
4. फलों को एकत्रीकरण केन्द्रों तक अत्यन्त सावधानी से पहुंचाएं ताकि प्रापण किये गए फल खराब न हों।
5. स्कैब ग्रस्त/इथरल स्प्रे किये हुए फल का प्रापण मण्डी मध्यस्थता योजना के अर्न्तगत नहीं किया जाएगा।
6. 51 मि.मी. से कम डायामीटर वाले फल सरकार द्वारा नहीं खरीदे जाएंगे। अतः बागवानों को चाहिए कि वे ऐसे फल, फल एकत्रीकरण केन्द्र तक न लाएं।
7. उक्त योजना के अर्न्तगत फलों का प्रापण केवल उत्पादक से ही किया जाएगा अर्थात् ठेकेदारों अथवा उनके प्रतिनिधियों से कोई फल नहीं खरीदा जाएगा।
8. मण्डी मध्यस्थता योजना के अर्न्तगत सेब का प्रापण केवल उन्हीं बागवानों से किया जाएगा जिनके पास उद्यान कार्ड उपलब्ध होंगे। प्रत्येक केन्द्र प्रभारी को प्रापण किये गए फलों की प्रविष्टि उक्त उद्यान कार्ड में करनी होगी तथा कार्ड में बागवान के हस्ताक्षर भी करवाने होंगे जिससे कि फल प्रापण में अनियमितताएं न हों।
9. मण्डी मध्यस्थता योजना के अर्न्तगत एक बोरी में केवल एक ही किस्म का फल लिया जाएगा।
10. जो फल बागवानों द्वारा फल एकत्रीकरण केन्द्र पर लाया जाएगा, केन्द्र तक उसका किराया-भाड़ा एवं अनलोडिंग व्यय बागवानों द्वारा स्वयं वहन किया जाएगा।
11. सड़ा-गला, पक्षी का खाया हुआ व दागी फल नहीं लिया जाएगा। अतः बागवानों को चाहिये कि वे ऐसे फल, एकत्रीकरण केन्द्र पर न लाएँ क्योंकि ऐसे फलों की छंटाई, भराई इत्यादि पर जो व्यय आएगा उसे बागवान को वहन करना पड़ेगा।
12. प्रदेश सरकार ने यह निर्णय लिया है कि मण्डी मध्यस्थता योजना-2023 के अर्न्तगत सेब का प्रापण: 35 कि०ग्रा० जूट की बोरियों में या प्लास्टिक क्रेटस में वास्तविक भार के हिसाब जिसमें 2.5 % अतिरिक्त फल वाष्पीकरण-उत्सर्जन और श्वसन हानि (Evapo-transpiration and respiration losses) के एवज में लिया जायेगा।
13. केन्द्र प्रभारी यह सुनिश्चित करेंगे कि फल तोलते समय बोरी के भार को भी मध्यनजर रखते हुए अतिरिक्त फल लें।
14. प्रभारी, एच.पी.एम.सी.एवं हिमफैड के प्रापण केन्द्रों पर प्रापण किये गए सेब की बोरियों के उपरी भाग अर्थात् सुतली/स्थान पर क्रमशः लाल (एच.पी.एम.सी.) एवं हरी (हिमफैड) स्याही से मार्क करेंगे तथा प्रेषण के समय प्रत्येक बोरी/पैक पर इसी स्याही/रंग से सेब प्रापण केन्द्र का कोड नम्बर भी अंकित करेंगे।
15. सेब से भरे बोरियों को इस तरह से खाली/प्रयोग करे ताकि यही बोरियां अगले साल प्रयोग में लाई जा सकें और बागवानों का उचित दामों पर उपलब्ध करवाई जा सकें।
16. प्रापण किये गए फलों के एवज में रसीद, केन्द्र प्रभारी तभी जारी करेगा जब उसने फलों को पूरी तरह से चैक कर लिया हो। फलों को चैक करते समय अर्थात् उन्हें भरते समय

- यदि फल निर्धारित माप—दण्ड के न हों तो स्वीकार न करने का पूरा अधिकार प्रभारी को होगा।
17. फलों की प्राप्ति के एवज में जारी की गई केवल वही रसीद मान्य होगी जोकि प्रभारी द्वारा जारी एवं हस्ताक्षरित की गई हो। अन्य व्यक्ति अथवा अधिकारी द्वारा जारी रसीद सरकार को मान्य नहीं होगी और न ही ऐसी रसीद के एवज में अदायगी लेने हेतु बागवान हकदार होगा।
 18. रसीद जारी करते समय केन्द्र प्रभारी शब्दों एवं अंको में बोरियों की संख्या एवं फलों की मात्रा साफ—साफ अक्षरों में रसीद में अंकित करेंगे तथा साथ में दिनांक सहित अपने हस्ताक्षर भी करेंगे। इसके अतिरिक्त रसीद पर बागवान के हस्ताक्षर भी दिनांक सहित करवाने अनिवार्य होंगे।
 19. फल एकत्रीकरण केन्द्र पर प्रापण कार्य केन्द्र प्रभारी द्वारा प्रातः 10 बजे से सांय 5 बजे तक किया जाएगा तथा केन्द्र रविवार को बन्द रहेगा।
 20. केन्द्र प्रभारी प्रतिदिन सांय चौकीदार से प्रापण किये गए फलों की बोरियों की संख्या एवं मात्रा के एवज में उनसे रसीद प्राप्त करेंगे व दूसरे दिन प्रातः इनकी पुष्टी करेंगे ताकि फलों के प्रापण एवं प्रेषण में कोई अनियमितता न हो।
 21. फल प्रापण में सरकार तथा बागवानों को वित्तीय हानि न हो, इसके लिये बागवानों को चाहिये कि वे एकत्रीकरण केन्द्र पर फल, केन्द्र प्रभारी द्वारा निर्धारित दिनांक को ही लाएँ ताकि प्रापण किये गए फल का प्रेषण शीघ्रतिशीघ्र सम्भव हो सके।
 22. केन्द्र प्रभारी का यह कर्तव्य होगा कि वह प्रापण किये गए फलों को धूप व वर्षा से बचाएँ ताकि फल खराब न हों।
 23. अस्थाई भण्डारण किये गए फल, धूप व वर्षा से बच सकें इसके लिये केन्द्र प्रभारियों को चाहिये कि वे तरपाल इस प्रकार से लगवाएँ कि फलों की बोरियों एवं तरपाल की उंचाई में कम से कम 5 फुट का अन्तर हो। ऐसा करने से धूप एवं गर्मी का प्रभाव फलों पर अधिक नहीं होगा तथा फल अधिक दिनों तक सामान्य तापमान पर भी रखा जा सकेगा। तरपाल, फल तोलने की मशीन व अन्य प्रापण सामग्री, प्रापण संस्थाओं द्वारा प्रभारियों को फल एकत्रीकरण केन्द्र पर उपलब्ध करवाई जाएगी।
 24. केन्द्र प्रभारी को प्रापण व प्रेषण किये गए फलों की सूचना एच.पी.एम.सी.एवं हिमफैड के उप कार्यालय एवं वरिष्ठ विपणन अधिकारी(उद्यान), हिमाचल प्रदेश को प्रतिदिन (सिवाए रविवार के) प्रेषित करनी होगी।
 25. बागवान तथा इस कार्य पर लगाए गए अधिकारी यह सुनिश्चित करेंगे कि सेब प्रापण में कोई अनियमितता न हो अन्यथा वे साँझे तौर पर उत्तरदायी होंगे।
 26. सरकार ने यह भी निर्णय लिया है कि उक्त योजना के अर्न्तगत फलों को बिक्री करते समय यदि कोई बागवान/असमाजिक तत्व केन्द्र पर प्रभारी से दुर्व्यवहार करता है तथा 51 मि.मी. से कम डायामीटर वाले फल या क्षतिग्रस्त, कम भार /गले सड़े फलों को जबरन केन्द्र प्रभारी को देने की कोशिश करता है तो उस परिस्थिति में केन्द्र प्रभारी को केन्द्र बन्द करने का अधिकार होगा तथा सरकार ऐसे मामलों में कोई ढील नहीं बरतेगी।

Annexure-‘II’

QUALITATIVE (QUALITY) GRADE STANDARDS FOR PROCUREMENT OF PROCESSING GRADE MANGO FRUITS UNDER MIS – 2023.

1. Mature fruits and unripe achari mango would be procured under the Scheme.
2. Fruits would be procured only in crates having capacity of about 20 Kgs., each.
3. The crates irrespective of the size would be returned to the fruit growers to the procurement agencies.
4. 2.5% more fruit in weight would be procured from the fruit growers for which no receipt would be issued it means that in 20Kgs. crate, 20.500 Kgs. of fruits would be procured and receipt would be issued for 20 Kgs., only, which do not include the weight of the crate.
5. Fruits would be procured only from those orchardists who possess Horticulture Card and who owned 10-00 Bighas or less land under Mango cultivation, no fruit would be procured from the contractors or other involved in the trade.
6. All the expenses including the transportation costs and unloading of fruits at the collection Centre would be borne by the fruit growers and expenses incurred after the procurement of fruit would be borne by the procurement agency.
7. It would be highly desirable on the part of fruit growers that they would bring the fruits of different varieties of seedling as well as grafted mangoes in separate crates so that it becomes convenient for the procurement agencies, processors and consumers to sell/ utilize the procured fruit in an optimal manner.
8. In no case the fruits of seedling, grafted mango varieties and unripe achari mango would be accepted in the same crate.
9. The fruits should be intact, sound, clean and free from foreign smell / taste.
10. The fruits with punctured skin, bird eaten would not be accepted.
11. Fruits having slight defects in shape, slightly hail damage and those having other minor defects like anthracnose spots with black tip and sooty blotch etc. would be accepted under the scheme.
12. Fruits having severe attack of fungal diseases / insect / pests or rotten fruits would not be accepted.
13. Wind fallen or shriveled fruits would not be accepted under the scheme.
